AN ORDINANCE SUSPENDING OPERATION AND ENFORCEMENT OF SECTION R501.3 OF INTERNATIONAL RESIDENTIAL CODE- ONE AND TWO FAMILY BUILDINGS, 2012 EDITION

WHEREAS, pursuant to Ordinance 13-52 adopted 12-10-13, the Village suspended operation of Section R501.3 of the International Residential Code- One and Two Family Buildings, 2012 Edition, ("IRC") until January 1, 2014;

WHEREAS, the Village is investigating methods of providing fire protection equivalent to that provided by R501.3 of the IRC but at substantially lower cost;


WHEREAS, it is therefore appropriate to suspend operation and enforcement of IRC Section 501.3 for another 60 days;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: IRC 2012 Section R501.3 "Fire Protection of Floors" shall be effective only as to building permits issued on or after March 1, 2014 and shall not govern any building permits issued before March 1, 2014.

SECTION 2: This Ordinance shall be effective upon its passage, approval and publication as required by law. The Clerk shall publish this Ordinance in pamphlet form. The Building Permit officer shall provide a copy of this Ordinance to all persons who have obtained building permits since the adoption of Ordinance No. 13-19 and will provide a copy of this Ordinance to persons seeking permits through March 1, 2014.
