**AN ORDINANCE PERTAINING TO BUILDING INSPECTORS
AND ADDING SUBSECTION (C) TO SECTION 150.21
OF THE VILLAGE OF CHATHAM CODE OF ORDINANCES**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, AS FOLLOWS:*

SECTION 1: Subsection (C) is hereby added to Section 150.21 of the Village of
Chatham Code of Ordinances, as follows:

(C) The Building, Electrical, Plumbing and Life Safety Inspectors shall
be agents of the Village and as such, are entitled to all the immunities of agents,
which are defined as “employees” in the Local Governmental and Governmental
Employees Tort Immunity Act.

SECTION 2: This Ordinance is declarative of the intent of Section 150.21 of the
Code of Ordinances as it has heretofore existed, and is adopted to clarify the status of the
inspectors at the request of one of the inspectors. This Ordinance effective immediately. The
Clerk shall publish this pamphlet form and see to its inclusion in the next update of the Village
Code of Ordinances.
