WHEREAS, the Village advertised and obtained bids for the reconstruction of W. Walnut Street from Illinois Route 4 to Church Street intersection; and

WHEREAS, the Public Works Committee met to review the bids and is recommending the lowest bid from McIntire and Company for \$1,498,184.38, to be paid from the Tax Increment Allocation Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the bid from McIntire and Company for \$1,498,184.38 is hereby approved.

SECTION 2: The Village Manager is hereby directed to complete the contract, notice of award and notice to proceed documents at the appropriate timing.

SECTION 3: This Ordinance is effective upon its passage and approval.

The Village of Chatham received proposals on March 13, 2014 for the referenced project and the results are as follows:

1. McIntire & Company \$1,498,184.38
2. Perry Broughton Trucking & Excavating \$1,664,028.74
3. Laverdiere Construction, Inc. \$2,049,911.55
4. Otto Baum Company Inc. \$2,098,700.35
5. Engineers Estimate \$1,316,480.00

The bid of \$1,498,184.38 is 13.8 percent over the engineer's estimate. There seems to be some inflation on some of the bid items that was unexpected on my part as the estimating engineer. You will note that McIntire's bid is 11.1 percent lower than the next lowest bidder.

McIntire & Company has done between six and seven million dollars of sewer work in Taylorville, Illinois in the past two years and we did not have any trouble or any extra costs on any of his projects.

I recommend that the Village accept McIntire & Company's proposal in the amount of \$1,498,184.38. Enclosed for your information are the bid tabulations for the project.
