ORDINANCE NO. 14- - 16

*AN ORDINANCE PERTAINING TO POLICE SALARIES*

**WHEREAS**, the President and Board of Trustees of the Village of Chatham have determined that it is in the best interest of the Village to maintain a well-trained, professional police force; and

**WHEREAS**, the Village Board has determined that pay for police officers who serve the Village must be commensurate with surrounding and competing departments to assist in providing a stable force of trained officers.

**WHEREAS**, the Administrative Committee is recommending the following salary schedule for Officers of the Village of Chatham Police Department.

***NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS AS FOLLOWS:***


**Section 1:** The Police Officers of the Village of Chatham shall be paid per the following salary schedule:

Sergeants

An officer who is promoted to Sergeant shall earn a rate of pay of 8% more than the rate of pay of an officer with the same total years of service during their first year in the position. Upon completion of their first year as a Sergeant the rate of pay shall be 10% more than the rate of pay of an officer with the same total years of service. Upon completion of two years as a Sergeant the pay rate shall be 12% more than the pay of an officer with the same total years of service.

**Section 2:** This Ordinance shall be in full force and effect upon passage and approval.
