ORDINANCE NO. 18- 6

AN ORDINANCE AMENDING TITLE III REGARDING THE NUMBER OF POLICE SERGEANTS

WHEREAS, the Village of Chatham (“Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village Code currently provides there are three police sergeant positions; and

WHEREAS, the Village Board desires to increase the potential number of police sergeant positions to four for the purpose of addressing potential vacancies and needs as they arise.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Amendment. Title III, Chapter 32, Section 32.11(B) shall be amended as follows:

§ 3211(B) SERGEANT
There ~~shall~~ be ~~three~~ four Police Sergeant positions in the Village Police Department.


Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. Effective Date. This Ordinance shall be in full force effect upon approval and publication in pamphlet form as provided by law.
