ORDINANCE NO. 19-19

AN ORDINANCE APPROVING A LEASE AGREEMENT WITH MARTIN EQUIPMENT FOR THE LEASE OF A MINI EXCAVATOR

WHEREAS, the Village of Chatham, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Illinois Municipal Code, Section 11-76-6, provides the corporate authorities of each municipality may enter into a lease for a period of not to exceed 5 years for such equipment and machinery as may be required for corporate purposes when authorized by the affirmative vote of two-thirds of the corporate authorities; and

WHEREAS, the Village sought quotes for the lease of a mini excavator and due to the specialized nature of the equipment, the Village Board desires to waive any of its applicable formal bidding requirements; and

WHEREAS, Martin Equipment is offering a 5-year government operation lease of a mini excavator for a total amount of \$44,335.00; and

WHEREAS, the Village Board desires to enter into a lease agreement with Martin Equipment for the lease of the equipment as set forth herein.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. <u>Authority to Execute Lease Agreement</u>. The Village President is authorized to execute a lease agreement, and related documents, with Martin Equipment, on the terms set forth on Exhibit A, for the lease of a mini excavator, as

described on Exhibit A.

Section 3. Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

Section 4. Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

Section 5. Effective Date. This Ordinance shall be in full force and effect immediately after its passage, approval and publication in pamphlet form as provided by law.




