AN ORDINANCE APPROVING A 90-DAY EXTENSION OF THE TERM OF A WATER SYSTEM INTERCONNECTION AGREEMENT BETWEEN THE CITY OF SPRINGFIELD AND VILLAGE OF CHATHAM

WHEREAS, the Village of Chatham, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois; and,

WHEREAS, the Village entered into an Agreement with the City of Springfield to utilize its water supply distribution system as an emergency water backup supply to the Village; and

WHEREAS, the Agreement was approved by Village Ordinance 16-06; and

WHEREAS, the Agreement had a term of 5 years which is set to expire; and,

WHEREAS, the Village and City wish to extend the Agreement for a period of ninety (90) days to negotiate a new water interconnection agreement; and,

WHEREAS, the Village Board of Trustees and the President of the Village of Chatham believe it is in the best interests of the Village to extend the term of the Agreement as provided for herein.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Approval of 90-Day Extension of the Term of the Water System Interconnection Agreement. The Board of Trustees of the Village hereby authorizes the Village President to extend the term of the Water System Interconnection Agreement with the City of Springfield as approved by Ordinance 16-06 for a period not to exceed ninety (90) days.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effectiveness. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
