ORDINANCE NO. 21-

AN ORDINANCE AUTHORIZING THE PURCHASE OF 17 TASERS FROM AXON ENTERPRISE, INC. FOR THE POLICE DEPARTMENT

WHEREAS, the Village of Chatham (“Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village Police Department has recommended and the corporate authorities of the Village desire to purchase 17 model Taser 7 from Axon Enterprise, Inc., to be utilized by the Village Police Department, based off the Illinois joint purchasing list; and

WHEREAS, Axon Enterprise, Inc. will credit the Village in the amount of \$1,336.20 for the purchase of 17 model Taser 7 as part of the overall purchase agreement; and

WHEREAS, the total amount of the 17 Tasers after accounting for the \$1,336.20 credit is \$45,943.69; and

WHEREAS, the actual funding for the 17 Tasers will be paid out of the Village’s General Fund; and

WHEREAS, the Village Board further finds it is in the best interest of the Village to authorize the purchase of these tasers.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Authority to Purchase Tasers. The Village President is authorized to execute any and all necessary documents to effectuate the purchase of the 17 model Taser 7 from Axon Enterprise, Inc., to be utilized by the Village Police Department, from the Illinois joint

purchasing program at an amount of \$45,943.69. The Village Clerk is authorized to attest to the same.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
