**ORDINANCE NO. 21-**

**AN ORDINANCE AUTHORIZING THE PURCHASE OF A 2006 INTERNATIONAL  
7400 TANDEM TRUCK AND ITS ACCESSORIES**

**WHEREAS**, the Village of Chatham (“Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village desires to purchase a 2006 International 7400 Tandem truck with its accessories (conveyor, reverse plow, and tailgate chipper) for use in maintaining its roads for \$25,000.00; and

**WHEREAS**, the Village Board of Trustees has determined it to be in the best interest of the Village to purchase the 2006 International 7400 Tandem truck and its accessories.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** Authority to Purchase Vehicle and Accessories. The Village President is authorized to execute any and all necessary documents to effectuate the purchase of the 2006 International 7400 Tandem truck and its accessories for an amount of \$25,000.00, and the Village Clerk is authorized to attest to the same.

**Section 3.** Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 4.** Repeal and Savings Clause. All ordinances or parts of ordinances in conflict


herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

**Section 5. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
