**ORDINANCE NO. 22-**

**AN ORDINANCE ACCEPTING THE LOW QUOTE FOR A TRUCK TO BE USED BY  
THE STREET DEPARTMENT**

**WHEREAS**, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

**WHEREAS**, the Village requested bids for a truck for its street department; and

**WHEREAS**, the Village solicited quotes from three dealers for vehicles matching its requirements and also published a request for bid in the Chatham Clarion; and,

**WHEREAS**, the Village received three quotes: (i) Friendly Chevrolet for a 2023 Chevrolet Silverado 2500HD for \$46,505.24 after applicable rebates; (ii) Victory Lane Ford for a 2022 Ford F250 Super for \$52,476.00; and (iii) Victory Lane Ford for a 2022 Ford F250 Super for \$58,640.00; and,

**WHEREAS**, the Village intends to accept this quote from Friendly Chevrolet; and,

**WHEREAS**, the Village Street Department had budgeted sufficient funds for the purchase of this vehicle; and,

**WHEREAS**, the Board of Trustees of the Village believe it is in the best interest of the Village to accept the quote from Friendly Chevrolet as attached hereto.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2.** Acceptance of Quote. The Village hereby approves quote from Friendly Chevrolet in the amount of \$46,505.24 as further described in the attached **Exhibit A**. Any and all quotes and parts thereof not explicitly approved by this Ordinance are hereby rejected. The

Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the purchases contemplated therein.


**Section 3. Severability.** In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 4. Repeal and Savings Clause.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

**Section 5. Effectiveness.** This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
