ORDINANCE NO. 23-30

AN ORDINANCE APPROVING TREE LIMB AND BRANCH COLLECTION SERVICES IN THE VILLAGE OF CHATHAM FOR AUGUST AND SEPTEMBER 2023

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village requested bids for limb and branch collection services within the Village of Chatham; and

WHEREAS, the Village solicited bids in accordance with Illinois law for proposals from companies willing and able to provide the services requested, and the Village opened all bids on July 20, 2023; and,

WHEREAS, the bid documents made clear that the Village reserved the right to accept or reject any and/or all parts of the bid; and,

WHEREAS, the Village received one bid and has not decided whether to accept the bid or reject all bids; and

WHEREAS, the existing contract for limb and branch collection services expired on July 31, 2023, but the need to continue the services uninterrupted exists; and

WHEREAS, the Village wishes to contract with Brown Storm Service to continue to provide limb and branch collection services for August 2023 and for September 2023, if needed; and,

WHEREAS, the Village intends to waive the competitive bidding requirements to the extent needed to contract for limb and branch collection services for September 2023; and

WHEREAS, the Board of Trustees of the Village believe it is in the best interest of the Village to enter into such agreement with Brown Storm Service for limb and branch collection services for August 2023 and for September 2023, if needed.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Authorization to Contract. The Village hereby agrees to contract with Brown Storm Service to continue to provide limb and branch collection services for the month of August 2023 in exchange for \$20,833.34; and agrees to contract with Brown Storm Service for September 2023 in exchange for \$20,833.34 but only if such services are needed because a bid for the services has not been approved as of September 1, 2023. To the extent that the total exceeds \$25,000.00, the Village hereby waives the competitive bidding requirements. The Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the contracts contemplated herein.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
