

RESOLUTION NO. 32-89

A RESOLUTION APPOINTING A VILLAGE TREASURER

WHEREAS, Section 3-8-1 of the Illinois Municipal Code empowers the Village President to appoint a Village Treasurer, with the advice and consent of the Board of Trustees; and

WHEREAS, the Village of Chatham has a legal requirement to appoint a Village Treasurer to conduct the Village's finance business; and

WHEREAS, the present Village Treasurer has submitted a letter of resignation;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS AS FOLLOWS:

SECTION I: Commencing December 1, 1989, MR. DONALD FUENER of Chatham is hereby appointed VILLAGE TREASURER.

SECTION II: Commencing December 1, 1989, the compensation for the said position will be \$550.00 per month and payable each month at the same time as other village employees receive compensation.

SECTION III: Commencing December 1, 1989, Mr. Fuener will occupy the office of Village Treasurer for one year, at which time he will be eligible for renewal of contract.

SECTION IV: The Village of Chatham will execute a treasurer's bond in Mr. Fuener's name.

SECTION V: This resolution shall be effective upon passage and approval as provided by law.

WHEREAS, DONALD FUENER has been appointed Treasurer of the Village of Chatham, in Sangamon County, Illinois, and


