

RESOLUTION 21-92


A RESOLUTION APPOINTING MEMBERS OF THE

In May 1992, I accepted a partnership position (future) with Greene & Bradford, Inc. in Springfield, IL. The work includes both public and private infrastructure jobs. Various projects include the design and construction of a 20 acre truck terminal in Lincoln and the associated utilities and 2,000 foot roadway to the site just off of Interstate 55. Also, I am serving as Village Engineer for the Village of Chatham.

From May 1990 to April 1992, I served as a project manager with Kuhlmann Design Group in Edwardsville for various IDOT and other municipal highway projects that included Phase I and II work in Districts 6, 8 and 9. Contract projects varied from \$250,000.00 to 2,500,000.00. I also worked on other municipal street improvements with contracts over \$500,000 that included work in Edwardsville, Caseyville and Fairview Heights.

From September 1986 to April 1990, I worked for SGR Engineering in Belleville, on many small and large projects. They consisted of watermain and sewer projects including lift stations, subdivision and site work including detention analysis; and other right of way and negotiation work. Project manager duties include attending Village and Township Board meetings, client development, marketing proposal and contract work and assisting on an in-house QA/QC program.

From December 1984 to August 1986, I worked for M.T.A. Inc. in Springfield, on several large projects for I.D.O.T. The first was a location-design study along seven miles of I-74 through Champaign-Urbana. Main responsibilities were studying mainline alternates, cost estimates, redesign (Intersection Design Studies) of four interchanges, prioritizing improvements, benefit-cost analysis and report preparation. Other projects included contract plans and specifications for a 3.3 mile segment on Illinois Route 26 in Freeport, Illinois. Work consisted of drainage, geometrics, cost estimates, and maintenance of traffic. Also I was project manager on the FAP 413 location-design study near St. Louis from I-270 to north of Alton terminating at U.S. 67. This work included studying route locations and cost estimates for H.B.A./I.D.O.T.

From March 1983 to October 1984, I worked for Martin Engineering Company. Responsibilities consisted of planning, designing and the construction inspection of various local subdivisions, other work included providing field assistance for design work as well as property surveys, using the COGO computer program to aid in writing legal descriptions, and planning/designing of a three mile water main extension project.


Upon graduating from the University of Illinois, I accepted a position with Hanson Engineers, Inc. as a Civil Engineer - Transportation and was an employee from January 1980 through November 1982. During this period, my experience included the following: planning and environmental studies, designing contract plans, preparing right-of-way documents, surveying, and inspecting construction projects. Responsibilities also included using the in-house PRIME 350 PCOGO program on analytic geometry for surveying, right-of-way and road design.
