(c) Utilities and Public Works Committee.

1. Trustee Williamsen, Chairperson, with primary responsibility for water and sewer systems.

2. Trustee MoGuire, with primary responsibility for street and sidewalk maintenance.

3. Trustee Krueger, with primary responsibility for construction of new public works.

4. Trustee Hilt, with primary responsibility for the electric system.

(d) Administration Committee.

1. Village President Koester, Chairperson, with primary responsibility for police.

2. Trustee Josw<sup>1</sup>ak, with primary responsibility for finance, the Recreation Commission and franchises.

3. Trustee Miller, with primary responsibility for personnel.
