**A RESOLUTION CONTINUING THE EMPLOYMENT
CONTRACT OF DEL MCCORD, VILLAGE ADMINISTRATOR,
THROUGH AND INCLUDING JUNE 11, 1993**

WHEREAS, the Employment Contract of Village Administrator, Del McCord, expires on May 11, 1993 with the taking of office of the new Village President;

WHEREAS, the corporate authorities of the Village of Chatham need thirty days through and including June 11, 1993 to decide whether to retain Mr. McCord for another extended term of office as Village Administrator, or to identify another suitable candidate;

WHEREAS, Mr. McCord has agreed to remain in office as the Village Administrator for an additional thirty days and to extend his contract for an additional thirty days.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, AS FOLLOWS:

SECTION 1: Mr. Del McCord is hereby appointed Village Administrator of the Village of Chatham through and including June 11, 1993.

SECTION 2: Mr. McCord's Contract of Employment is hereby extended an additional thirty days through and including June 11, 1993.

SECTION 3: This Resolution is effective immediately.
