A RESOLUTION PROCLAIMING 4-H DAY

WHEREAS, 4-H IS AN EDUCATIONAL EXPERIENCE FOR CHATHAM AREA YOUTH AND ADULTS BASED ON THEIR INTERESTS AND NEEDS, 4-H HELPS THEM TO IDENTIFY AND WORK TOWARD PERSONAL GOALS, CONTRIBUTE TO AND ASSUME LEADERSHIP IN THEIR COMMUNITY, COUNTY, STATE COUNTRY AND WORLD; AND


WHEREAS, 4-H IS DIRECTED TOWARD THE DEVELOPMENT OF LIFE SKILLS IN INITIATING INQUIRY, USING SCIENCE AND TECHNOLOGY, RELATING TO PEERS AND ADULTS, IMPROVING MENTAL AND PHYSICAL HEALTH, DEVELOPING COMMUNICATIONS SKILLS AND MAKING VOCATIONAL CHOICES; AND

WHEREAS, 4-H IS AN EFFECTIVE EDUCATIONAL PROGRAM BASED ON THE EXPERTISE OF THE UNITED STATES DEPARTMENT OF AGRICULTURE, AND UNIVERSITY OF ILLINOIS PLANNED BY LOCAL, COUNTY, AND STATE COMMITTEES, AND IS FINANCED BY PUBLIC AND PRIVATE MONEY; AND


WHEREAS, 4-H IS A FAMILY AND COMMUNITY EFFORT SUPPLEMENTING AND COMPLEMENTING THE HOME, CHURCH AND SCHOOL WITH ACTION ORIENTED AND PRACTICAL EDUCATIONAL EXPERIENCES FOR OVER 197,000 ILLINOIS YOUTH UNDER THE LEADERSHIP OF MORE THAN 16,500 VOLUNTEERS; AND
