**A RESOLUTION AUTHORIZING A PETITION FOR PARTICIPATION BY  
SANGAMON COUNTY IN THE PLUMMER BOULEVARD RAILROAD BRIDGE  
PROJECT**

*BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** The Village President is authorized and directed to execute and file a petition requesting the participation by Sangamon County in the Plummer Boulevard Railroad Bridge Project, which petition shall be generally in the form attached hereto as Exhibit A, with such minor emendations as may be required by the County.


**SECTION 2:** If the Petition is granted, the proper officers of the Village are authorized and directed to proceed with the project as set forth in the petition and to secure any necessary approvals thereof from the Illinois Commerce Commission or other agency involved in the project.

**SECTION 3:** This Resolution is effective immediately.

COUNTY BRIDGE PETITION

I, Linda Koester, Village President for the Village of Chatham, Illinois do hereby petition the County Board of Sangamon County for aid in the construction of a grade separation structure located near the SPCSL tracks at Plummer Blvd, Chatham, Illinois. The estimated cost of this grade separation structure is \$2.3 million with the Local Agency's share of the cost estimated to be \$200,000. This cost is more than 0.02% of the value of all the taxable property in said Village, as equalized or assessed by the Department of Revenue, and the tax rate for corporate purposes in said Village was in each year for the 2 years last past not less than the maximum rate provided for in Section 5/5-501 of the Illinois Highway Code.

The Village agrees to pay one-half of the Local Agency's cost of said grade separation structure.

This petition is conditional upon approval by the Illinois Commerce Commission of the substitution of Sangamon County for the Village of Chatham as lead agency for this project.


