

RESOLUTION NO. 40-06

**A RESOLUTION ABATING THE DIRECT ANNUAL REAL ESTATE TAX  
IN THE AMOUNT OF \$248,439 FOR THE YEAR 2006  
LEVIED PURSUANT TO ORDINANCE NO. 06-64**

WHEREAS, pursuant to “An Ordinance Of The Village Of Chatham, Sangamon County, Illinois, Authorizing The Issuance Of General Obligation Bonds (Alternate Revenue Source), Series 2006, Of The Issuer In An Aggregate Principal Amount Not To Exceed \$3,410,000 For The Purpose Of Defraying The Cost Of Improving The Electric System Of Said Issuer,” Ordinance No. 06-64, the corporate authorities of the Village of Chatham levied a tax for the levy year 2006 in the amount of \$248,439 to cover principal and interest charges for the year 2007 for those certain bonds designated as “General Obligation Bond (Alternate Revenue Source) Series 2006”;

WHEREAS, Section 15 of that Ordinance provides that in the event there are sufficient Pledged Revenues (as defined in that Ordinance) on hand in an amount not less than the debt service on the outstanding bonds for the period for which the taxes were levied, the Village Board shall duly direct the abatement of such taxes and timely file the same with the County Clerk;

WHEREAS, the Treasurer of the Village of Chatham has reported, and the corporate authorities find, that there are sufficient Pledged Revenues (as defined in that Ordinance) on hand in an amount not less than the debt service on the outstanding bonds for the period for which the taxes were levied;


WHEREAS, the direct annual real estate tax levied pursuant to Ordinance No. 06-64 for 2006 must therefore be abated.

*NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*


**SECTION 1:** That certain tax levied for the year 2006 in the amount of \$248,439 to cover principal and interest charges for 2007, which tax was levied pursuant to Section 15 of "An Ordinance Of The Village Of Chatham, Sangamon County, Illinois, Authorizing The Issuance Of General Obligation Bonds (Alternate Revenue Source), Series 2006, Of The Issuer In An Aggregate Principal Amount Not To Exceed \$3,410,000 For The Purpose Of Defraying The Cost Of Improving The Electric System Of Said Issuer," Ordinance No. 06-64, is hereby abated.

**SECTION 2:** The Clerk of the Village of Chatham is hereby directed to file forthwith a certified copy of this resolution with the County Clerk of Sangamon County, Illinois.


