**A RESOLUTION THE BLUECROSS AND BLUESHIELD HEALTH INSURANCE
PLAN FOR FISCAL YEAR 2018**

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village has been presented with a proposed health insurance plan renewal from BlueCross and BlueShield, with a proposed increase less than 2.5%, and the Corporate Authorities believe it is in the best interest of the Village to approve said renewal.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.



The Village Board of Trustees hereby approve the BlueCross and BlueShield healthcare plan renewal for the Village of Chatham, with a monthly charge of \$62,850.11, and authorize the Village Manager, Village President and the Village Clerk to execute any necessary documents to effectuate the renewal.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.
