**A RESOLUTION APPROVING THE PURCHASE OF A FIELD PRO 6040 INFIELD GROOMER AND RELATED ACCESSORIES**

**WHEREAS**, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

**WHEREAS**, the Village maintains several baseball and softball diamonds in its Village parks which have dirt infields; and,

**WHEREAS**, to provide proper maintenance to the infields, the Village is interested in purchasing a new Field Pro 6040 and related accessories; and,

**WHEREAS**, Village solicited quotations for such vehicle through Sourcewell; and,

**WHEREAS**, MTI Distributing submitted a bid for a total of \$31,052.58 which included a Field Pro multitool, QAS drag mat carrier system, and steel drag mat as further set forth in the Quote attached hereto as **Exhibit A**; and,

**WHEREAS**, the Village Board of Trustees has determined it to be in the best interest of the Village to purchase the equipment as set forth herein.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:
