**A RESOLUTION CONFIRMING THE APPOINTMENT OF JOE SMITH TO THE
PUBLIC PROPERTIES & RECREATION COMMISSION**

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village has established the Public Properties & Recreation Commission (“Commission”); and,

WHEREAS, Village Code §33.01 provides that the Village President shall appoint individuals to the Commission with the advice and consent of the Village Board; and,

WHEREAS, the President hereby appoints JOE SMITH, whose term will expire in 2029; and,

WHEREAS, the Board of Trustees of the Village believe it is in the best interest of the Village to approve the appointment of JOE SMITH as a member on the Commission.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Appointment. The Village Board of Trustees hereby approves the appointment by the Village President of JOE SMITH, member on the Public Properties & Recreation Commission. JOE SMITH’s term shall expire on his appointment anniversary date in 2029.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.
